Booth Registration Information

Booth spaces are approximately 12' x 12'. Pricing for booths are based on Los Banos Chamber of Commerce **Membership** and **Non-Membership**. We also have pricing for non-profit groups. Health Department Fees for Food Vendors are \$50.00 for Low Risk (pre-packaged) and \$110.00 for High Risk (prepared on-site) Health Department fees must be paid 3 weeks prior to event date.

FOOD OR DRINK VENDORS ARE REQUIRED TO HOLD A VALID MERCED COUNTY HEALTH DEPARTMENT PERMIT FOR THIS EVENT. NO EXCEPTIONS TO THIS RULE! Vendors go to: www.co.merced.ca.us/eh and visit the Community Food Event Forms. **Submit your food/drink Vendor Application with a copy of Merced County Health Permit Application and all fees no later than November 28th, 2022. Food vendors with annual Merced County permit pay a \$40 processing fee and must show proof of annual permit.**

No vehicles are allowed on the streets except for loading and unloading.

NO VEHICLES ON STREET BETWEEN 6PM & 9:30PM. No sales of firearms, ammunition, alcoholic beverages or live animals will be permitted.
