### **Booth Registration Information**

Booth spaces are approximately 12' x 12'. Pricing for booths is based on Los Banos Chamber of Commerce Membership and Non-Membership. (PLEASE COMPLETE CORRECT APPLICATION BASED ON MEMBERSHIP AND NON-MEMBERSHIP) We also have pricing for non-profit groups. Health Department Fees for Food Vendors are \$75.00 for Low Risk (pre-packaged) and \$135.00 for High Risk (prepared on-site) Health Department fees must be paid 2 weeks prior to event date.

FOOD OR DRINK VENDORS ARE REQUIRED TO HOLD A VALID MERCED COUNTY HEALTH DEPARTMENT PERMIT FOR THIS EVENT. NO EXCEPTIONS TO THIS RULE! Ask Chamber office for Merced County Health Application. Submit your food/drink Vendor Application with a copy of Merced County Health Permit Application and all fees to Chamber Office no later than September 8<sup>th</sup>, 2025. Food vendors with annual Merced County permit pay a \$40 processing fee and must show proof of annual permit. No vehicles are allowed on the streets except for loading and unloading. NO VEHICLES ON STREET BETWEEN 8AM & 3PM. No sales of firearms, ammunition, alcoholic beverages, pornographic material, drug paraphernalia or live animals will be permitted. Chamber office has the right to ask you to shut down if you do not comply with rules.
